The TC74HC07A is a high speed CMOS BUFFER fabricated with silicon gate ${\rm C^2MOS}$ technology.

It achieves the high speed operation similar to equivalent LSTTL while maintaining the CMOS low power dissipation.

Pin configuration and function are the same as the TC74HCT7007A. But the TC74HC07A has high performance MOS N-channel transistor (open-drain) outputs.

This device can, therfore, with a suitable pull-up resistors, be used in wired-AND, LED driver and other applications.

All inputs are equipped with protection circuits against static discharge or transient excess voltage.



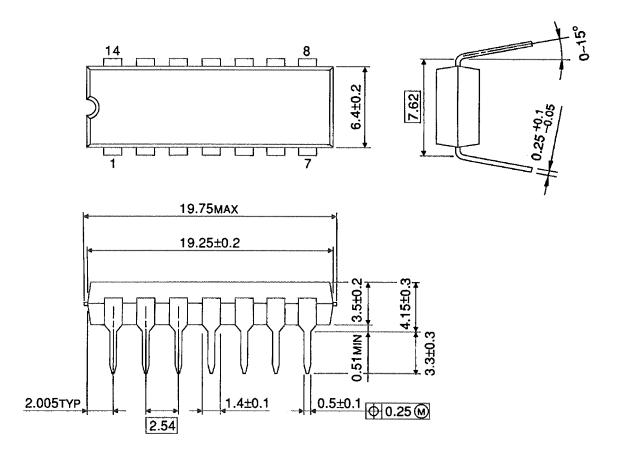

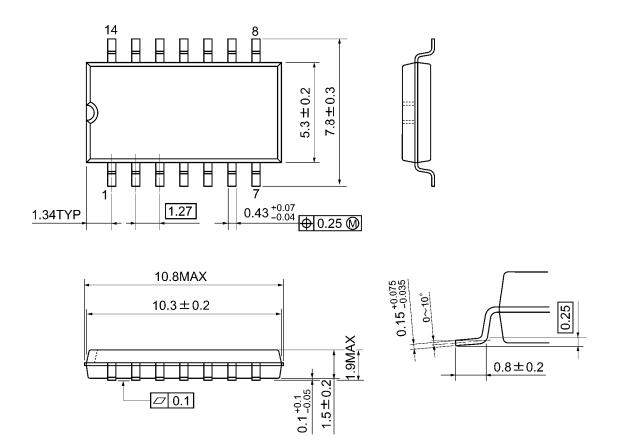
DIP14-P-300-2.54 Unit: mm
